Input for the ESSER III Plan has been both collective and specific. Collectively, input has been gathered during the development of the 2021-2024 LCAP Plan and the Expanded Learning Opportunities Grant Plan as both plans had overlapping areas of need that are also applicable to the ESSER III. Stakeholders, including teachers, district cabinet, families, students, bargaining units, families of unduplicated pupils, and school staff were given the opportunity to give feedback and share ideas on student academic needs, SEL needs, and learning gaps created by Covid. This was collected in a variety of ways, including surveys, Site Council meetings, NESD School Board meetings, NTA and CSEA reports, individual emails and comments, and more.

Newcastle Elementary School District evaluated its stakeholder engagement opportunities and determined that Tribes, Advocates, and Civil Rights Groups are neither present nor served by the LEA.

Specifically, input on the ESSER III was collected in the following ways. Both classified and certificated bargaining units were presented with ideas for ESSER III expenditures during preservice work days and given an opportunity to share ideas and feedback. Families, staff, and community members have made comments and suggestions regarding student academic needs, SEL needs, and learning gaps created by Covid at recent, monthly board meetings. District cabinet meetings discussed these topics and worked together to finalize the expenditure

plan. All other stakeholders were give the opportunity for feedback through board meetings and/or direct communication to the site principal and district superintendent.

Input previously collected from the LCAP and the ELOGP was used to help create the framework for the ESSER III. NESD has worked to align expenditure plans and plan goals to make best use of funding resources. The goals of providing interventions, learning technology to support intervention, staffing, SEL support, and a safe school environment were identified in past plans and ESSER III funding will continue to be aligned to these priorities. Input gathered specifically for the ESSER III from district cabinet, classified and certificated bargaining units, and through school board comments from the public as well as the trustees helped create a framework for staffing and programs that is reflected in the proposed expenditure plan.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
